IMPORTANT NOTES:

1. The device must not be capable of generating a dangerous evolution of heat.
2. The device must not be capable of emitting disturbing signals, such as buzzing alarms or strobe lights, during transportation.
3. Transportation of all types of batteries contained within the devices is subject to the requirements of IATA Dangerous Goods Regulations including documentation, marking, and labeling.
4. All devices are required to be properly declared on the Air Waybill at booking and acceptance. The brand/manufacturer name and model as listed above must be inserted on the Handling Information column of the Air Waybill accompanied by the special handling code: EMD.
5. flydubai approved devices may be denied for transportation on interline routes operated by another airline. Prior arrangements must be made at the time of shipment booking.
6. Personnel involved in preparing shipments with cargo tracking devices and data loggers must receive adequate instruction on the requirements commensurate with the functions for which they are responsible.
